I am directed to invite your attention to Rule 4.7 read with Rule 4.9-A of Punjab Civil Services Rules Vol-I, Part-I, wherein the provision regarding annual increment have been enshrined. Rule 4.9-A of Punjab Civil Services Vol-I, Part-I reads as under:

"Notwithstanding anything contained in the foregoing rule, the annual increments shall be allowed with effect from the first day of the month in which they fall due under the normal rules regulating increments."

2. As per this Rule, only Government employees are entitled to annual increment and a pensioner is not entitled to it. But in cases where increment falls due on the first day of the month, after the date of retirement, it is not admissible at present as there is no such provision in the rules.

3. In view of plethora of Court Cases being filed for the grant of annual increment, which falls due on the first day after the date of retirement, the Department of Finance, considered the issue in detail and it is clarified that no increase can be allowed in the pay of the Government employee after the day he ceases to be a Government employee and also his/her pension can not be calculated on any pay which is more than the last pay drawn as per rules.
