Minutes of the Monthly Meeting of the District Education

Officers held on 10.04.2008

1.0 A meeting was held on 10.03.2008 at Mahatma Gandhi State Institute of Public Administration, Chandigarh to review the implementation of SSA Programme and Mid Day Meal Scheme. Director General School Education cum State Project Director chaired the meeting.

2.0 The list of officers who attended the meeting is at **Annexure A.**

3.0 **Action Taken Report by the DEOs on the previous meeting**

The following observations are made regarding the Action Taken Report on the decisions taken in the meeting held on 10.03.2008 and prior to that:-

- (1) Reply on the Audit Observations are still pending from districts Amritsar, Ludhiana, Jalandhar, Moga, Faridkot, Ropar, Muktsar and Sangrur.
- (2) Inspection reports on Remedial Coaching are still awaited from the districts of Ferozepur, Gurdaspur, Kapurthala, Moga and Ropar
- (3) Up gradation of EGS centres to regular schools is still pending in the districts of Bathinda, Hoshiarpur, Jalandhar, Kapurthala, Mansa, Faridkot, Ludhiana, Muktsar and Sangrur.
- (4) No Inspection Report of any VEDC was carried out by the districts of Mansa and Mohali during the month.
- (5) ASPD EGS is still to get the matter finalized on instructions of minimum size of land required for up

gradation of EGS centres to primary schools

- (6) Procurement of the material under ECCE component has still not been done by the districts of Mansa and Mohali.
- (7) DEO Sangrur and Kapurthala did not send the regular monthly statement to the DMF in the prescribed format till date.
- (8) The districts are still to send the information regarding the funds which are lying un- utilized with the VEDCs.
- (9) The districts of Sangrur, Fatehgarh Sahib, Faridkot, Ropar, Mohali and Kapurthala did not hold any monthly meeting of District Education Development Committee during the month of March, 2008
- (10) DEOs did not examine the appraisal note circulated to them for the Annual Plan 2008-09
- (11) District Ferozepur has not provided the information regarding the details of teachers who did not attend the Teacher Training programme conducted during the month of December, 2007
- (12) DEOs of the districts Bathinda, Nawanshaher and Jalandhar have sent the video recording made by them regarding the absence of teachers to the Head Office.

4.0 Finance:

- a) It was apprised by Deputy Manager Finance in the meeting that funds as per details given below have been released to the districts against the approved plan of the districts and various categories.

b) All DEOs (EE) were advised to send the monthly reports of the funds spent in the prescribed formats as circulated them from time to time by 5th of following month by all means.

c) All districts are still to send the information regarding the funds un-utilized with the VEDCs. All concerned DEOs were advised to send this information without any delay.

d) DMF informed that Rs. 140 crores (approx.) has

been transferred to the districts that have further been transferred to the VEDC or blocks as advised. However, the utilization certificates are still to be received in the Head office. All DEOs were strictly advised to ensure that the utilization certificates against the advances should be sent to the Head Office expeditiously.

e) All DEOs were advised to send the audited balance sheet duly signed by the DEO by 25/04/2008.

f) DMF was informed that TDS has not been deducted by the districts on the salary released by them to the employees. All DEOs were advised to do the needful without any delay.

5.0 Textbooks and Planning

(a) It was noted that Punjab School Education Board has failed in carrying out its commitment to deliver the books in the districts by deadline fixed by the SSA. Mr. Rahi, the concerned officer from Punjab School Education Board was present in the meeting. However, he could not give the detailed information regarding the books delivered to the districts. He was requested to give the detailed information regarding all 59 titles for the classes Ist to VIIIth by Monday i.e. 14/04/2008.

(b) DEOs informed that there have been many shortcomings / difficulties faced by them while dealing with Punjab School Education Board in quality and distributing the books. It was further pointed out that while the books are available on private shops, on the same moment, it can be made available to the DEOs for further distribution to the students. No district till date has received the full quality of books. In some of the districts there has been a huge shortage of books.0.

(c) DEOs pointed out that quality of paper used by Punjab School Education Board has been very poor. Further, there have been instances of the printing error.

(d) The representative of Punjab School Education Board was asked to expedite the delivery of the books in the districts within another seven days or so.

(e) All concerned ASPDs have visited their respective districts allotted to them and have submitted their report. It has come to the notice that adequate logistic arrangements were not made by the DEOs. It has resulted in wastage of transport, money and time. DEOs were advised to make out a route chart and send the vehicle from the district head quarter itself to deliver the books in the schools. All DEOs were requested to distribute the books to the students and shall ensure that no book is kept lying either at the block level, cluster level or district level.

(f) The detailed position of the books lying in the D.E.O. office was reviewed and the following position is emerged:

g) The information given by DEO Ferozepur appears to be doubtful. She was asked to review the information and give the report to the Head Office. DMF being the component head incharge of the district was also advised to look into it.

h) All DEOs were reiterated once again that all usable stock of the current year should be effectively utilized and distributed among the students. The unusable stock was kept under lock. DEOs were advised to review this position once again and send the consolidated information to the ASPD Planning within fortnight. Necessary guidelines shall be issued to utilize or dispose off such books which could not be utilized by the students.

6.0 Remedial Coaching:

a) It was noted that the funds under the Remedial Coaching (RC) have already been released to the districts. However it has generally been observed that there is no monitoring on the part of the DEOs to ensure whether Remedial Coaching classes are being held regularly or not. **All concerned DEOs were advised to inspect such schools and send their report.** They were also advised to send list of such schools so as to get it cross verified and evaluated from some different agencies.

b) The issue was discussed in detail in the meeting as to how to plan the Remedial Coaching in the current academic session. It was generally decided that the implementation of Remedial Coaching may be left to the concerned head of institution. They may be given flexibility to engage a teacher either of the same school or a well qualified

unemployed youth or a teacher from a nearby area. However, a strong monitoring mechanism be followed by the head office to monitor the performance of the Remedial Coaching continuously.

7.0 Civil Works

a) It was apprised in the meeting that the funds as per the details given below have been released to the districts for further utilization under the civil works.

b) All District Education Officers were advised to ensure that the quality of the works is never be compromised. They were further advised to get these works inspected through the committees constituted by Head Office at district level.

c) As per the information available in the office, the list of EGS centres which were required to be upgraded as

Primary Schools is placed at **Annexure B**. However the same has not been upgraded till date due to non availability of land or otherwise. **All DEOs (EE) were advised to take up the matter with their Deputy Commissioners and take further necessary action.**

d) All DEOs may randomly inspect the work of the VEDCs and submit the report to the office. They were also advised to get the details of those funds which are lying with the VEDCs and send the same to the Head Office.

e) It has been noted that the utilization of funds in the civil works has been found poor i.e. below average in the districts Amritsar, Bathinda, Faridkot, Ferozepur, Gurdaspur, Jalandhar, Ludhiana, Mansa, Moga, Muktsar, Patiala, Ropar and Sangrur.

f) It has been noted that funds are not being utilized under the BALA Scheme whereas the States like Himachal Pradesh have utilized the building as learning aid optimally in their schools. It was decided that a team at the head office level shall be constituted who shall visit the State of Himachal Pradesh and thereafter prepare an action plan to implement the scheme all over the State. **All DEOs were advised to get in touch with AM Civil works and take further necessary action.**

g) Execution of Civil Works was reviewed. It was noted that the works in case of one BRC, 141 CRC, 5 new school buildings, 352 additional classrooms Primary, 504 additional classrooms for upper primary, 157 major repairs, 712 Building as Learning Aid (BALA) and 358 ramps have still not be taken up despite the fact that funds have been released by the Head Office since long back. It was further noted that the CRCs are pending mainly in the districts of Ferozepur, Patiala, Ludhiana and Jalandhar whereas the additional classrooms both for primary and upper primary are pending in the districts of Amritsar, Gurdaspur, Ludhiana. All

DEOs were advised to execute the works expeditiously.

8 EGS/AIE Centres:

- a) List of all EGS Centre which are required to be upgraded during the current financial year i.e. 2008 has already been circulated in all the districts. DEOs have confirmed the availability of land for all the centres. It was decided that DMF may release the funds as per the norms against these EGS centres so that the DEOs can get this work started without any further delay.
- b) The matter of conducting examination of class Vth by Punjab School Education Board came up for discussion during the last meeting also. ASPD EGS was requested to get the matter processed at the Head Office and issue directions to the DEOs after obtaining the orders of the competent authority.
- c) ASPD EGS was advised to examine and put up the instructions of the State Government on the minimum size of the land requirements and the minimum strength of the students before the school is opened.
- d) The matter of the main streaming of the out of school children in the age group of 6 to 8, the students in the EGS / AIE Centres were reviewed in detail. ASPD from the Head Office have also visited the districts and submitted their reports. The detailed position on the mainstreaming of the students in the above said categories emerged as per the details given below:

e) Regarding the mainstreaming of the children in the age group of 8 to 14, it was decided that necessary action may be taken by conducting the Bridge Courses through NGOs who will be selected by the process of open advertisements by Grant - in - Aid Committee constituted under the chairmanship of Secretary School Education. ASPD EGS was advised to issue the notices for this meeting as advertisement has already given in the newspaper. DEOs were advised to ensure that these NGOs once selected by the competent authority mainstream these children.

f) DEOs were advised to appoint a Nodal Officer which each school or a near by school who is to take care of the children who are out of school studying in EGS / AIE

Centres.

g) DEOs were advised to continue to maintain effective monitoring of out of school children in EGS centres. **Works of district Gurdaspur, Barnala, Mansa, Muktsar, Nawanshaher, Fatehgarh Sahib and Moga was appreciated in the meeting in this regard.**

9. Planning

a) It was noted that the copy of the appraisal note of the Annual Plan 2008-09 was circulated to all the DEOs who were requested to examine it. However, the DEOs could not examine the appraisal note and hence the same could not be discussed. All DEOs were advised to comply with these directions by the next meeting.

10. Teacher Training

a) It was noted that despite directions some of the designated BPEOs / Centre Head Teachers have not attended the training programmes being conducted by the Head Office at Mohali. The DEOs were advised to take strict disciplinary action and submit the report in the next monthly meeting (after getting the details from ASPD TT)

b) All DEOs were advised to ensure that the benefit of the earned leaves be given to all the teachers within the respective jurisdiction against the days on which the teacher attended the training programmes during the month of June, 2007.

c) No report has been received in the office on the use of Teacher Learning Material by the schools. All DEOs were advised to bring the information in the enclosed performa (revised performas for various components are enclosed herewith)

11. IED & ECCE

a) Section Officer informed that the recruitment of

the IERT teachers has been completed in the districts. All DEOs were advised to ensure that the IERT teachers join their duties and carry out their duties sincerely.

b) However, the DEOs of district Amritsar (1), Barnala (2), Bathinda (3), Hoshiarpur (8), Jalandhar (3), Ludhiana (2), Mansa (1), Moga (2), Nawanshaher (3), Ropar (1), Sangrur (1) and TarnTaran (4) have not taken up their duties. In case they do not join, IERT teachers may be appointed from the waiting list.

c) No resource room has been set up in the districts of Barnala, Bathinda, Jalandhar till date. DEOs were advised to ensure that the resource room is set up immediately. Remaining DEOs were advised to make the resource room functional by procuring hardware if required.

d) The districts of Amritsar, Barnala, Bathinda, Fatehgarh Sahib, Ferozepur, Hoshiarpur, Jalandhar, Ludhiana, Mansa, Moga, Mohali, Muktsar, Patiala, Ropar, Sangrur and Tarn Taran have not utilized the funds released to them under the ECCE component for providing Teacher Learning Material etc. to the Anganwari.

(e) It was noted that disability certificate to the students is not being issued by the concerned Civil Surgeons. A letter in this regard has already been written to the Deputy Commissioners and Civil Surgeons. DEOs were advised to follow up the matter with the Civil Surgeons and Deputy Commissioners and submit the report regarding the certificate issued to such students.

(f) It was noted that IERT teachers are supposed to provide Home Based Education as well as to visit the schools regularly. However, some of these IERT teachers are stated not to visiting the schools nor do they take much action in providing Home Based Education. **It was decided that a performa to measure their performance to be circulated by the head office to all the DEOs which they will further**

circulate and advise the BPEO and other functionaries to collect the report from the IERT teachers about the work done by them.

(g) DM (IED) was advised to follow up the matter of holding workshop in consultation with Bhoj University.

12. Miscellaneous Issues

a) All DEOs were advised to examine the results of the examination conducted recently and submit a report during the next monthly meeting.

b) It has generally come to the notice that regular reports are not coming from the DEOs regarding the renewal of the contract agreements with the employees which causes avoidable hardship to the employees. DEOs shall now send their reports by 25/04/2008 to the Section Officer in the Head Office failing which all agreement shall be renewed by the Head Office under the presumption that the conduct and the performance of the employees has been good during the year. If some cases of mis conduct or embezzlement was deducted, only the DEOs shall be responsible for not reporting such matters in time to the Head Office.

c) DEOs were advised to identify the number of plants which they can surely plant during the coming monsoon seasons in the schools. DEOs were requested to follow it up further.

d) It was noted that BRPs are not doing the work as expected or desired from them. All DEOs were advised to clearly allocate the territorial jurisdiction of such BRPs and ensure that the BRPs effectively work within their territorial jurisdiction. They may further continue to assist component wise to the BPEOs.

e) DEOs were requested to apply their mind on the proposal as to whether only the BPEOs should continue to work as the Block Resource Coordinator or in his place a

senior most BRP need to be appointed as BRC.

13. Issues which are pending with Head Office

- (i) Approval of BRPs is pending in district Jalandhar. Proposal is yet to be received from the DEO Jalandhar as informed by Section Officer in the meeting;
- (ii) Computers for Mid Day Meal cell;
- (iii) APC (G) needs to be posted in district Mohali;
- (iv) Providing Xerox machine in district Jalandhar, Kapurthala, Patiala, Ropar & other districts as per the requirement;
- (v) Fax machine in district Moga and other districts and for Circle Education Officers as per the requirement as per the rules;
- (vi) The matter relating to settlement of Rs.51 lacs of district Amritsar;
- (vii) DEO Muktsar needs to clarify the matters relating to BRC/CRC in writing. AM/CW may examine the matter after obtaining orders on file;
- (viii) DEO Sangrur needs to be issued advise regarding utilization of the money amounting to Rs. 4.78 lacs;
- (ix) Release of salary to the employees kept through outsource agency in district Tarn Taran and elsewhere under the Mid Day Meal cell;
- (x) It was informed by the DEOs that there are IERT teachers contract has not been renewed. Section Officer informed that the necessary reports have not been received from the DEOs and as a result these cases might be pending. It was decided that all the DEOs either send the report by 25/04/2008 positively failing which it shall be assumed that they had none adverse against these IERT teachers and contract shall be

renewed as per the rules of the procedure. In case come compliant or irregularities come to the notice subsequently, the entire responsibility shall be of the DEOs concerned. Similar decision was taken in respect of other employees posted in SSA;

- (xi) DEOs pointed out that the post in Mid Day Meal cell is lying vacant and the same shall be filled up expeditiously;
- (xii) Filling up of the managers post in Nawanshaher and Patiala;
- (xiii) Salary of the staff employed in Mid Day Meal cell through outsourcing agencies in various districts;
- (xiv) Clarification to DEO Jalandhar as to whether he can use the funds of the SSA towards the consumption of petrol as he has got the vehicle by the Government for carrying out the activities of SSA;
- (xv) Cases of BRP / DRP in Fatehgarh Sahib;
- (xvi) Change of site for EGS centre for upgradation of schools in district Ludhiana;
- (xvii) Transfer of staff to Barnala from Sangrur;
- (xviii) Approval of the appointment of the DRC in district Gurdaspur and Sangrur;
- (xix) Approval of Residential Bridge Courses in Ropar;
- (xx) Case of APC (F) in Bathinda;
- (xxi) Management cost is to be released to DEO Tarn Taran;
- (xxii) Guidelines to be issued to the districts regarding the funds lying with them under SSA;
- (xxiii) Guidelines regarding disposal of DISE data
- (xxiv) Orders of the DRP monitoring the Girls Education and SC / ST Education in all the districts.
